The Operator/Service Provider/Project Mandator is requested to give a written confirmation of acceptance of the cost. Based on above fees structure, a detailed estimate of the overall cost will be send before each inspection.
- III. Payment: An advance payment of 100% of the overall estimated cost is obligatory. Balance payment is requested immediately after the report has been finalized. A detailed invoice will be submitted.
- IV. All taxes: will be extra as applicable from time to time.
- V. Above mentioned are standard rates subject to change (12 hour is per may-day).
- VI. Courier cost will be charged at actual whenever applicable.
- VII. Tariff applicable for Governmental Organizations, Institutions, and Tender based projects will be based on the criteria defined in the agreement, excluding lab analysis and additional charges etc.

For Projects or Company or Institution having several ICS or Unit under them fees will be charged as per agreement for the project excluding additional/unannounced audit, TC charges and Lab Analysis (for NPOP) if any.

- VIII. Above tariffs may vary from time to time. It is the responsibility of clients/operator/or all concerned to see the Fees Structure for latest updated Fees Structure.
- IX. 0% refund if is available during or after inspection or non-submission of NC Closures within given deadline or stipulated time after Audit. 0% refund if a Denial of Certification has been issued after inspection and review. Only 10% and 25% of the actual fees deposited shall be refunded back respectively if the operator withdraws the project; (i) prior to more than 15 days of proposed date of inspection, or prior to less than 15 days and more than 03 days of the proposed date of inspection.
- X. The reason may be non-submission of NC Closures before stipulated time or expiry of grace period or six months of registration, non-receipt of data within six months of registration etc. Denial of Certification reason shall vary and is not limited to given reason, it can vary from case to case and decision of CGCERT' s Certification Committee shall be binding. It shall be the sole discretion of CEO, CGCERT on refund related issues, refund policies or any other related matter regarding certification fees.
- XI. Decision of CEO, CGCERT shall be final and binding upon the parties in all circumstances. CEO CGCERT reserves all rights to increase or decrease fees. In case of confusion related to any interpretations of the conditions stipulated herein above, decision of CEO CGCERT shall be final and binding.
- XII. The provided estimate will be based on the information given by the operator and includes the anticipated scope of work. The final invoiced amount may exceed the initial estimate if justified for valid reasons. Additional time required for inspection or certification due to the operator's shortcomings or services not included in the original offer will incur extra charges. Furthermore, inspections mandated by the certification committee or investigations arising from major non-compliance will also be billed accordingly. Please note that one man-day equals 12 hours. In case of Grower Groups estimate will be based on the initial risk assessment, considering the minimum number of samples to be verified. If a higher risk is observed, additional samples may need to be inspected, potentially requiring more man-days for verification.
